### A Recognition Award for Exceptional Service to the School

Contextually numerous independent schools in Australia, New Zealand and across the Commonwealth recognize outstanding individuals who have benefited the success of their organization.

This would then mean that the School has the following ways of formally acknowledging success of alumni and/or community members who have contributed to our ongoing success.

This proposal is for the formation of a new group to be recognised by the School "Grammar Greats".

Membership of this group is for those who have given outstanding voluntary service to the School over an extended period of time.

To become a member you must be nominated by the community and the nomination would be considered by a Grammar Great Awards Committee. The membership of the Committee would be the Board Chair, Principal, President of the Old Launcestonian Association (and 2 other nominees.

The Board would consider this to be the most prestigious award that may be given to an individual.

The criterion for selection is outlined in the draft nominations form below.

The award is to be presented at the annual Presentation Speech Day/Night by the Board Chair and is an opportunity for graduating students to see the importance of Service to School by Alumni and former Community members.

- 2. Service which is rendered in a variety of ways rather than within a narrow scope of activity.

"Voluntary service" is construed literally and therefore precludes anyone remunerated in any way by the School in the course of providing relevant services (e.g. present and former staff members and employees performing services in those capacities are precluded from nomination

# "Exceptional service" means:

- 1. Service over and above the ordinary performance of the roles undertaken by the nominee for the School;
- 2. Service which significantly distinguishes the nominee from his or her peers in the performance of those services; <u>and</u>
- 3. Service which has a significant and beneficial impact on the School and its well-being.

"Good repute" means enjoying a reputation which is not tainted by anything which would (either directly or indirectly) bring the nominee or the School into disrepute or which would otherwise impact adversely on the standing of the nominee or of the School in the public

arena.
